Once rented, rented fees will not be refunded. In case of cancellation or inclement weather, the renting parties will be give the opportunity to reschedule the event at no additional charge.

(Under no circumstances may the renting party use public property for the purpose of making a profit).

I, the undersigned, for myself and any person associated with the event, will be responsible for any damage done at (Check One) ___ Freedom Park or ___ Paul Henry Park during the event time specified above. I agree that there will be an inspection of the park following the event by a representative of the Town and if damages are found, I agree to pay for the needed repairs. I further agree to the following:

- (1) I will clean the shelter(s) and/or playing field(s)/areas after use.
- (2) I will provide my own trash/garbage bags.
- (3) I will dispose of garbage in appropriate trash cans, as provided.
- (4) If tables are rearranged, I will place them back as found.
- (5) Upon leaving the shelter(s), I will check to be sure urinals and commodes are flushed (but not left running) and all lights are off.
- (6) Please report any accidents or any damage immediately to (336) 622-3955.
- (7) During the event mentioned above, the undersigned party must have a copy of this form to serve as proof of rental.

I, the undersigned, for myself and any person associated with the event, do hereby release, indemnify, hold harmless and defend the Town of Liberty, its agents and employees from all suits and action, including the attorney's fees and all cost of litigation and judgement of every name description brought against the Town of Liberty as a result of loss, damage or injury to person or property that may occur during my use of Freedom Park or Paul Henry Smith Park and insure that I will faithfully comply with the terms of this agreement.
