#### To Order

The Mayor welcomed everyone and noted all Council Members were present.

#### Pledge of Allegiance/Invocation

Mayor Filmore York asked Council Member Larry Coble to lead the Pledge of Allegiance and then the Mayor asked everyone to join in a Moment of Silence.

## Adoption of Agenda

Council Member Don Herndon made a motion to adopt the agenda with the addition of 9.1 Budget Amendment #17 and a Closed Session per NCGS 143-318.11 (a) (7)... Council Member Tyson Nixon seconded the motion which passed unanimously: Council Member Larry Coble voted yes, Council Member Don Herndon voted yes, Council Member Tyson Nixon voted yes, Council Member Terry Caviness voted yes, and Council Member JR Beard voted yes. The agenda was approved with the addition of the Closed Session.

Audit Presentation - Austin Eubanks - 2022 audit - Thompson, Price, Scott, and Adams Austin Eubanks gave an overview of the Audit and where to find items. Top three revenues are on page 8. Top three expenditures are on page 9. Information on ARPA funds is on Page 12. Water/Sewer is on Page 14. Significant Deficiencies (page 16) were failure to perform reconciliations of significant accounts and timelines for audit submissions. Hopefully the 2023 audit will be completed in 2023.

Council Member Larry Coble asked about our water rate increase. Mr. Eubanks said there are two things you can do to increase cash flow, raise rates or reduce expenditures which



have increased due to inflation. Rates needed to be increased. Town manager Scott Kidd said we increased rates as of July 1, 2023 which will not show until the 2024 audit. Mr. Eubanks said there are a lot of grants included in revenues that show as fixed assets but the operational side is losing money due to spending more than was brought in. The Town Manager said water/sewer and General have less cash on hand. Nets went up because of more assets (vehicles and buildings). With being behind on audits it is hard to see where we were and where we were going. Council Member Larry Coble said let's get the budget done on time and deal with these issues. The Town Manager said our previous auditor asked for an extension every year. Council Member Tyson Nixon said he thinks every department should be broken out separately. Council Member Coble said he would like to see debts for each department.

## Code Enforcement Report - Nicole Mabe

Code Enforcement Officer Nicole Mabe was unable to attend due to her husband having the flu but Town Manager Scott Kidd said he can reach out with specific questions.

## Finance Report

Finance Director Kathy Bond came forward to give her report on the month of October. Sales and Use tax is up 7.45%. DMV taxes are up 16.63% and property taxes are up 172.68%. Processed Payroll for October was \$191.031.63 and processed AP was \$313,085.32. Council Member Don Herndon asked why property taxes are so high and the Town Manager said due to the County's reevaluations.

Council Member JR Beard made a motion to approve the Finance Report. Council Member Tyson Nixon seconded the motion which passed unanimously with Council Members: Larry Coble, Terry Caviness, Don Herndon, JR Beard, and Tyson Nixon voting yes.

## Approval of Minutes

Council Member JR Beard made a motion to approve the minutes from the Work Session October 16, 2023, and Council Meeting October 23, 2023. Council Member Larry Coble seconded the motion which passed unanimously: Council Member Don Herndon voted yes, Council Member Tyson Nixon voted yes, Council Member JR Beard voted yes, Council Member Terry Cavienss voted yes and Council Member Larry Coble voted yes. The minutes were approved.
